The second is the Guerilla Eye Service (GES). The Guerilla Eye Service also provides screening exams, refractions, and free glasses for the underserved by taking the eye clinic to the communities in need. The clinic is run by medical students and is set up in different locations throughout Pittsburgh primarily on Saturday mornings from 9PM -1PM. The students are first- and second-year students with one student who acts as the clinic coordinator. There are two UPMC ophthalmology residents who help mentor the students as well as refract all the patients. Each clinic also requires an attending physician. This is where we come into the picture. GES is always looking for faculty volunteers. I have volunteered multiple times and found it to be a fun and rewarding experience. The patients are extremely grateful, and it is a really nice opportunity to interact with the medical students and residents. I am always impressed by what a terrific job they do at their level of training. It is also fantastic to see medicine through their eyes. The wonder and enthusiasm they have for medicine is a refreshing change from the normal daily routine. Please consider volunteering for these clinics. Our participation is needed, and we are really making a difference in the lives of those in need. Email Jake Waxman if you would like to be added to the email list of volunteers for the GES.

The last topic I would like to cover is membership to our local and state societies. If you do not already have membership to the Pennsylvania Academy of Ophthalmology (PAO), Allegheny County Medical Society (ACMS), and the Pennsylvania Medical Society (PAMED) PLEASE join. The benefits they provide for all of us are substantial. Among other things the PAMED has free CME, a lot of which is required for renewing our PA medical license. I find it to be an incredibly concise and easy process to get through. That alone is worth the membership in my opinion! ACMS provides association management services for our organization. This is invaluable as we would not be able to run the POS in an efficient and smooth manner without their administrative expertise.

So, let's talk about the PAO. They also provide free CME, grand rounds, a Young Ophthalmology division with early practice education and the Business of Ophthalmology (BOO) educational series for residents and ophthalmologists. But in my opinion the most important thing the PAO provides is their continued legislative efforts. We all need to be a part of that effort by supporting the PAO with our continued membership.

One of the important issues the PAO is working on is the optometrist supported bill (HB562 and SB 780) that mandates comprehensive exams for every child multiple times regardless of lack of issues or complaints. There is no medical benefit whatsoever for these exams. Mandatory screening is already in place with act 122 which requires screening of all children prior to entering school then yearly though grade 5 and every other year from grades 6-12. Comprehensive exams are required if screening is failed. We all know our pediatric ophthalmology colleagues are extremely busy. If this bill is passed it will overwhelm an already overloaded system with healthy children, putting those in need at risk of not being seen in a timely manner.

What will really help is for all of us to build relationships with our legislators and talk to them about these and other health issues. The PAO provides talking points which are readily available on their website. So, let's all support the PAO and our other local societies by becoming members as well as contacting our local legislators.

Thanks to all our board members. Thank you to Nadine for her tireless work making sure everything goes according to plan and runs like clockwork! We have a great line-up of wonderful speakers for both the monthly and annual meetings. Enjoy the last days of summer, I look forward to seeing everyone again in September!

2024 Membership Dues Increase

I'd like to express gratitude for your continued support of the Society and to advise of an increase in membership dues for 2024. Due to increasing venue and overall meetings costs, the Board of Directors unanimously agreed to an increase. Membership dues will increase from \$400 to \$450 for 2024. This was not an easy decision, but it was necessary. The Society will continue to subsidize a portion of the costs for a member to attend a monthly meeting, and the increase in dues will decrease the cost per person to the Society.

The benefits and value of membership are strong. The POS is one of the few local specialty organizations that meet monthly and welcome 55 to 65 attendees each month. Treasurer's Report

The Society account balances remain stable, and we continue the trend of a profit from the Annual Spring meeting. Strong vendor support and a decrease in speaker travel fees aided in the profit.

For the 2022-2023 monthly meeting series (September 2022 through March 2023) the overall monthly meeting expenses increased due to an increase in venue prices and speaker travel expenses.

I'd like to thank members for registering for each meeting, as this impacts catering fees (we have a more accurate meal count for catering when members register, which keeps our costs to a minimum). Unfortunately, we saw a higher than anticipated number of members who registered and did not attend the meeting. This impacted on the expenses for each monthly meeting. Vendor support remained strong with the Society welcoming 1 to 3 vendors for each meeting. The Society relies on vendor support to reduce the cost of each meeting. We are actively working to secure 100% support for the 2023-2024 monthly meeting series.

Membership dues also are instrumental in sustaining our accounts. POS membership is an excellent value, not just for the CME credit, but for the updates on local and national issues, and the opportunity to hear distinguished national faculty at monthly meetings. I encourage all members to extend an invitation to their colleagues to join. Through a continued effort to expand membership and a strong focus on identifying sponsorship for support of the annual and monthly meetings, we look to continue to remain solvent for 2023-2024 and the future!

Legislative Update

Over the past year, the Pennsylvania Academy of Ophthalmology has been heavily engaged in Harrisburg. With the legislature on summer recess, it is a great time to learn about what PAO has been doing in Harrisburg over the past year.

Medicaid Reimbursement:

Over the past year, PAO has begun advocacy efforts with the Legislature and Governor's office to educate them about the need to increase reimbursement rates.

- The Commonwealth currently has one of the lowest reimbursement rates for patient visits in the country.

- Over 1.5 million children are served by Medicaid in Pennsylvania.

Increasing reimbursement will help to bridge the reimbursement gap for the physicians currently accepting Medicaid while incentivizing more physicians to accept Medicaid, thus helping to increase access for patients.

Mandatory Eye Examinations:

This year legislation has been reintroduced in both the House and Senate that would mandate unnecessary comprehensive eye exams or eye health and vision examinations for Pennsylvania's school-age children. The legislation as proposed (House Bill 562 and Senate Bill 720) would require that students receive a comprehensive eye exam or eye health and vision examination a minimum of three times throughout a child's school career.

Currently in Pennsylvania, students are required to receive a vision screening prior to enrolling in school for the first time. In addition, students are required to receive a vision screening every year from kindergarten through the 5th grade, and then every other year from 5th grade up through 12th grade.

Summer Advocacy:

The PAO has launched its summer advocacy campaign and we need your participation! This summer, with legislators at home until mid-September, is the perfect time to create a relationship with your elected officials or continue to maintain a preestablished relationship!

Pittsburgh Ophthalmology Society 58th Annual Meeting **- Highlights!**



The Pittsburgh Ophthalmology Society, under the leadership of President Marshall Stafford, MD, hosted their 58th Annual Meeting on March 10 at the Omni William Penn Hotel. The in-person event attracted over 90 physicians and welcomed distinguished ophthalmologist **Leon W. Herndon, Jr., MD,** who served as the 42nd Annual Harvey E. Thorpe Lecturer. Dr. Herndon presented several exceptional presentations.

The named lecture honors Harvey E. Thorpe, MD, an ophthalmologist whose techniques and inventions of medical instruments contributed to the study of the eye.

Dr. Herndon, Professor of Ophthalmology, Duke University Medical Center, Durham, North Carolina is member of the American Academy of Ophthalmology (AAO) and was a member of the first class of the Leadership Development Program. He currently serves as Chief of the Glaucoma Division at the Duke University Eye Center where he has trained 84 clinical fellows and was recently appointed the president of the American Glaucoma Society.
